SUBJECT: Comments on exchange of CINDA Data Bases and Dictionaries

In updating our CINDA library with the exchange files from areas 2, 3, and 4, we encountered some entries which we were unable to load.

Some of these required only dictionary updates. In those cases, we made the required update to our internal dictionaries and loaded the entries. A list of the dictionary updates is attached.

In other cases, either the entries were in error, or we could not determine if they were correct because we do not have the reference. A list of those entries is attached. We ask the appropriate center to make the required correction or dictionary update and then to retransmit the entries so that our data bases will again be the same.

We think that the other centers should consider improving their checking codes so that errors which affect the blocking are caught. This is especially important because, when they are loaded at one center and not at another, the centers files are no longer the same. Also, when the files are corrected, sending deletes for entries which do not exist is confusing.

On checking our list of forbidden reactions against the list in the CINDA manual, we encountered some differences. These are included in the list of dictionary updates.
