Publication and price of CINDA 1979/80

About the publication schedule of CINDA in the years 1979 and 1980 I refer to Memo 4C-3/227 which I understand as agreed.

About the criteria, which blocks to include in the volumes CINDA-A resp. CINDA-79, I refer to the letters by Peter Johnston 1978/9/13 and myself 1978/9/25.

About a tentative price estimate, as announced at the Paris meeting in June 1978, I refer to Memo 4C-3/223. This price estimate was subject to a more reliable estimate of the page-numbers (which increased since then by about 6%) and the development of the \$/AS exchange rate (which changed by 7% from June to December 1978, and further since then).

I have now obtained the official price estimates by the Agency's Division of Publications which is attached. It was stated earlier that part of the bill for 1979 can be paid in 1980, as was done for the last cumulative issue CINDA 76/77.

For the estimate of the page numbers the following figures were used, base on P. Johnston's letter of 78/9/13:

CINDA-A:

2000 pages of Cinda entries (excluding ca.100 pages of introduction, tables, etc)

corresponding to approximately 120 000 entries

CINDA-79:

325 pages of Cinda entries (excluding ca.75 pages of introduction, tables, etc)

corresponding to approximately 15 000 entries

Referring to your Interoffice Memorandum dated 14 November 1978 I should like to inform you that the subscription prices for CINDA 79/30 have been calculated as follows:

CINDA-A (archival issue) 1935-1976:

Two volumes à 1050 pages, format: 16,5 x 24 cm;

Date of distribution: 1 June 1979

Subscription price: US\$ 75.00 (AS 1,050.-)

CINDA 79 (1977-1979):

One volume with 400 pages, format: 16,5 x 24 cm;
Date of distribution: 1 June 1979
One supplement with 300 pages, format: 16,5 x 24 cm;
Date of distribution: 1 December 1979
Subscription price: US\$ 25.00 (AS 350.-)

CINDA 80 (1977-1980):

One volume with 600 pages, format: 16,5 x 24 cm;
Date of distribution: 1 June 1980
One supplement with 300 pages, format: 16,5 x 24 cm;
Date of distribution: 1 December 1980
Subscription price: US\$ 32.00 (AS 450.-)

Due to several economic measures it is possible to keep the same sales price per page (in Austrian Schillings) as in 1976/77, i.e. AS 0.50. It is, however, impossible to ignore the devaluation of the US Dollar. The UN exchange rate in 1976/77 was AS 18.60 for one US Dollar, the present rate is AS 14.00 per US Dollar only, which represents an actual loss of 25%.

The subscription prices have been calculated on the assumption that the firm orders from the NEA Data Bank and from the USA National Nuclear Data Center will not be curtailed.
