Comments on TRANS-2090

- 1. In all SUBENT records of this tape, the N_1 number was too high by 1. The error report sent to NEA-DB was produced after correcting this.
- 2. As far as we know, in the ¹⁹⁷Au(n,γ) reaction the metastable state ^{198m}Au is not activated. Therefore the product nucleus is to be coded neither 79-AU-198-G+M nor 79-AU-198-G but only 79-AU-198. (The -G extension in the reaction product field should be used only to define a partial cross section.) We corrected entries 20765, 20767, 20774, 21690 and 21768 accordingly.
- 3. In Subentry 21690.006, under ASSUMED a reaction combination (ratio of 2 reactions) is given. Although not mentioned in the Manual this is not possible because of the structure of the ASSUMED code (heading, reaction) where the reaction is not enclosed in extra parentheses. Since this is probably a rare case it would perhaps suffice to give these data under MISC (in particular in the case of this subentry where ASSUM3 is the ratio of ASSUM1 and ASSUM2). Please retransmit.
- 4. In subentry 21782.030 EN is missing but an angle is given which does not belong there. Retransmission is requested.
- 5. In subentry 21786.002 no ASSUMED value is given although defined in the BIB section. Retransmission is requested.
- 6. Entry 21751: Sample temperatures should be given in the COMMON section, not only in free text.
- 7. Subentry 21768.004:
