Please find attached our comments on EXFOR TRANS tapes 1204 through 1208, 2109, and 4061.

In TRANS 2108 and 2109, some mistakes occur systematically:

- 1) All BIB sections of all retransmitted subentries (which is most of TRANS 2108 and 2109) have wrong alter flags in col. 80 seemingly added automatically:
 - a) all 'BIB' records have a 'D' in col. 80 (which means that one or more following records were deleted which is not the case);
 - b) all other records of the BIB sections are marked with 'R'. This should be used only when a section is totally rewritten or has very many changes, however, in these TRANS tapes there are typically only 1 or 2 (or no) minor changes. We would (for future TRANS tapes) prefer having the individual changes marked as usual with C,I,D, in particular since no details are given under HISTORY either.
- 2) REFERENCE: if an issue-number of a journal is given, it must be put in parentheses.
- 3) Avoid opening parentheses in col. 12 within free text.
- 4) NOSUBENT records require an asterisk in col. 80.
