Subject: 1) FLAG in COMMON section

2) Comments on TRANS 2117

1) In entry 22036 (TRANS 2117), the heading FLAG is used in the COMMON sections of subentries 2 and 3 which is not allowed according to the manual (see Lexfor 'Flags'). In the case of entry 22036, if the keyword SAMPLE would be moved to subentries 2 and 3, no FLAG would be needed. There could, however, be other cases where FLAG in a COMMON section could perhaps be useful. We suggest to discuss at the forthcoming data centres' meeting whether flags in COMMON section disturb any of the centres. If this is the case, we would include such a check in the NDS Exfor check program.

## 2) Comments on TRANS 2117

Once again, we would like to draw NEA-DB's attention to the incorrect use of alter flags and missing HISTORY documentation of the changes made to re-transmitted entries, e.g.

- use of flag 'R' to mark single record changes, e.g. in 22017.002,3,4,5,6,7 (REACTION code). R should be used only when whole BIB, COMMON or DATA sections or large groups of records are Replaced.
- retransmitting subentries where the only change marked with alter flags is an inserted HISTORY line which, in turn, does not give any information on the update made (e.g. 22024.002,3,4).

Our other comments are given in the following table. For 6 entries we request retransmission.
