1. Request for retransmission of evaluated CPND and Decay Data contained in TRANS DOOL and DOO2 as "VIEN" series and deletion of this work from "EXFOR" series.

2. Errors and Problems noted in TRANS D002

3. Overlap in activities of CAJaD, NDS, and NNDC.

It is our understanding that the CPND EXFOR series should contain only experimental charged particle and photonuclear data. Therefore, we request that the following works contained on TRANS DOO1 and DOO2 be retransmitted as "VIEN" series works and removed from EXFOR:

D0001 (Evaluated CPND)
D0002 (Evaluated CPND)
D0003 (Evaluated CPND)
D0004 (Evaluated CPND)
D0014 (Evaluated CPND)
D6001 (Nuclear Structure and Decay Data)
D6002 (Nuclear Structure and Decay Data)

We also request that future transmissions of evaluated data and decay data be made on the VIEN series.

The following errors and problems were noted on TRANS D002:

D0008.002: The coded information (TOF) and (TELES) are missing for METHOD 1 and Method 2, respectively.

There is a missing volume number for MONIT-REF 2. It should read (,J.C. Hopkins +,J,ND/A,9,137,71).

Drosg's name is misspelled in the next line.

There also appears to be missing data. These include relative angular distributions, Legendre polynomial expansions, and the direct 13.36 MeV data.

D0008.003: The 13- and 15- MeV data appears to be missing along with the relative data and 13.36-MeV data. The original article quoted a total error of 3.4%; however, the quadratic sum of the errors coded is only 2.5%.

D0012.004: The error (1.5%) is missing from the appropriate field in COMMON.

D0014.002: The R-Matrix data contained in the table under ERR-ANALYS should be included in DATA.

D0014.003: Multiple Reaction and Vector Common are not allowed together.

D0014.004: In REL-REF, the period following D0015.001 should be replaced by ", ".

There has been some overlap in the compilation activities of CAJaD, NDS, and NNDC. These are the following:

D0002-D0007 corresponds to C0011

Since Drosg aided NDS in compiling these entries, we will kill ${\sf C0011}$.

D0008 corresponds to C0009 and C0013

If the problems noted above are resolved, we will kill our entries, since Drosg aided in the NDS compilation.

D0009 corresponds to C0010

These are virtually identical. We ask NDS to kill their entry.

D0012 corresponds to C0032

Since we were able to obtain the original data via M.D. Goldberg, we ask NDS to kill their entry.

A0018 corresponds to C0053

We began compilation of this work prior to the receipt of CP-A/15 and TRANS A002. We will kill our entry.
